Terms & Conditions

- 1) On receipt by us of your completed booking form we will reserve your holiday on our venue.
- 2) Your booking is taken to be confirmed and accepted in respect of all persons travelling when the invoice is dispatched to the person signing the booking form.
- 3) Your completed booking form showing all clients must be accompanied by your deposit. The deposit is accepted as part payment towards the total cost of the holiday.
- 4) The person signing the booking form confirms that he/she has the authority of all other persons included in the holiday to make the booking on their behalf and that he/she has read and accepted these booking terms and conditions. All bookings and departure dates are confirmed to (and all correspondence will be with) the person signing the booking form. The person signing the booking form is liable for all costs and charges on behalf of the party.
- 5) The balance of the cost of the holiday must be paid in full on arrival at the venue. All payments must be made in Euros.
- 6) In the event you cancel your confirmed booking, it can only be accepted if it is in writing from the person who signed the booking form. Deposits are non refundable.
- 7) You must have a valid UK passport. This is your responsibility and we accept no responsibility for any delay or expense incurred through any irregularity in your documents.
- 8) Force Majeure: We will not be liable for loss or delay occasioned by any of the following: Strikes, riots, Political unrest, hostilities, War or threat of War, Terrorist activity, Industrial disputes, Fire, Flood, Technical/Weather problems to transport, Closure of Ports, Weather conditions or any event(s) beyond our control.
- 9) We strongly recommend that you purchase personal trace and vehicle breakdown insurance and do not accept any liability of any financial loss incurred as a result of you not doing so.
- 10) Whenever possible any changes to the booking requested after written confirmation of the booking is sent out to you will be accommodated.
- 11) Jurisdiction: Signature of the booking form constitutes acceptance of a contract of these terms subject to English Law and the exclusive jurisdiction of English Courts.
- 12) Complaints Procedure: In the unlikely event that you or a member of your party has a complaint about your holiday; whilst at the venue, the complaint must be notified to the owner as soon as possible. No discussion about a complaint will be entered into once the client has left the venue.
- 13) Liability: The venue owner's liability shall be limited to the cost of the holiday as specified on the booking form.
- 14) A security deposit will be required for the accommodation when you arrive at the venue. This will be refunded in full when you leave, subject to deductions for any breakages, or extra cleaning costs incurred. Our venue is well run and we ask that you leave it in the same clean state as you found it.
- 15) The use of boats is entirely at your own risk. The use of a boat requires that you use a lifejacket and ensure adequate safety precautions are taken at all times. The venue accepts no liability for failure to comply with this requirement.
- 16) Our venue is primarily a fishing venue and the lakes may represent a risk for young children. Families accompanied by children are reminded that they do so entirely at their own risk. Adults are responsible for the safety and behavior of their children.
